Then I asked the public witnesses whether he have any weighing machine or balance. If he has whether he is ready to weigh the cannabis (Ganja). Then Sushanta Char, S/O- Lt. Narayan Char, of vill- Madhukunda, PS- Santuri, Dist- Purulia replied in writing and weighed the Cannabis (Ganja). After weighing it is found that white "Basta" (Marked as 'A') is contained with 24 Kg 700 gm. He gave a certificate regarding the result of weighing of the Cannabis (Ganja). Then I took three samples each contained with 100 gms Cannabis (Ganja) for taking follow up action. I seized, sealed, labeled the white "Basta" as 'A' and three sample packets as A1, A2, A3 and under proper seizure list duly signed by the witnesses.


On demand he could not produce any documents for the said Cannabis (Ganja). Accordingly I arrested him I informed him the ground for which he is arrested. I also asked him whether he is willing to inform any one regarding their arrest. He replied negatively. I issued Arrest memo and inspection memo. The entire search, seizure, labeling and arrest were done in presence of Sri Partha Chakraborty, WBCS (Exe), DM & DC, Raghunathpur.

So I started Santuri PS Case No- 61/18, Dtd- 11.10.18, U/S- 20(b) (i)/29 NDPS Act 1985, as Suo-motu against the accused persons namely (i) Gopal Gour, S/O- Bhajahari Gour of vill- Rudia, PO- Chainpur, PS- Chandil, Dist- Saraikela- Kharswan, Jharkhand and directed SI Mahadeb Rana of Santuri PS for its investigation.


