During inspection theft of Electricity was found, i.e. he/she was using Electricity dishonestly  
by drawing illegal hooking from the nearest  
L.T.O.H line of W.B.S.E.D.C.L.

Supply i.e. U/S 135 was detected.

From the above system he/she was using the following Electrical equipments i.e.

- 1) Incandescent Bulb - 2 NO'S = 60x2 = 120 watt
- 2) Ceiling fan - 1 NO'S = 60 = 60 watt

Out of them we seized the following:

Single core 1 wire approx 5 meter.

The impugned person left the above premises at about 05/11/18 on date 3:50 PM. The
