In producing here with one arrested accused person namely Biplab Chakraborty (44 Yrs.) S/O Lt. Hrishikesh Chakraborty of Kamlasthan PS- Adra Dist- Purulia along with following seized articles viz-

- 1) 01 (One) white colour plastic jarican containing approx 15 ltrs. of ID liquor.
- 2) 600 ml of ID liquor taken from Sl. No. 1 in a plastic bottle duly sealed and labeled as sample.
- 3) Sale proceed of Rs.- 60/-
- 3) Ten pieces of plastic glass.

I SI Bibekananda Ganguly of Adra P.S. do here by lodged a complaint against Biplab Chakraborty (44 Yrs.) S/O Lt. Hrishikesh Chakraborty of Kamlasthan PS- Adra Dist- Purulia to the effect that on 28.11.18 at about 17:35 hrs in course of my evening mobile duty I received a telephonic information from a reliable source that one Nitesh Kr. Yadav (28 Yrs.) S/O Bijoy Yadav of Kamalasthan, Adra, PS- Adra Dist- Puru Biplab Chakraborty (44 Yrs.) S/O Lt. Hrishikesh Chakraborty of Kamlasthan PS- Adra Dist- Purulia was stocked ID liquor illegally and selling the same to hike price for his personal gain then I informed O/C Adra PS and as per order of O/C Adra PS myself along with JC/572 Ajoy Giri & JC/340 Aswini Mondal rushed to the spot for raid by Govt. vehicle. At about 17:55 hrs. myself along with force reached at Kamalasthan and hold raid in the Jhupri (Kamlasthan) of Biplab Chakraborty found that said Biplab Chakraborty sealing liquor at his own Jhupri and seeing the Police party some person fled away and said Biplab Chakraborty to concealed himself but we are able to apprehend him and also detained him. I asked him to produced valid License or valid papers of selling country spirit but he failed to produced any valid license or documents for possessing/selling the same, So I arrested the above mentioned accused person informing the ground of arrest and seized the above mentioned articles after preparing proper seizure list duly sign by accused person and available witnesses.

Hence I there for pray that a specific case may kindly be started against arrested accused person namely Biplab Chakraborty (44 Yrs.) S/O Lt. Hrishikesh Chakraborty of Kamlasthan PS- Adra Dist- Purulia and arrange for its investigation.
