Bholanath Singh Mura of village Kuchi, P.O- Bagmundi, Dist- Purulia has committed theft of electricity U/S 135(1) (a) of electricity act 2003 subsequently amendment act 2007.

On 16/11/2018 at about 03.20 PM I Sri Swapan Kumar Das, AE & Station Manager, Bagmundih CCC along with 1. Sri Sukhamoy Maji (SAE) 2. Indrajit Bouri TSH. 3. — entered the premises of Sri Ranjit Singh Mura S/O- Lt Bholanath Singh Mura of village Kuchi P.O- Bagmundi, Dist- Purulia and found Sri Ranjit Singh Mura was enjoying electricity unauthorizedly drawing power from the nearest L & MV line of WBSEDCL through PVC wire by means direct hooking to his house premises and connected load found 0.100 KVA.
