

On 22.11.2018 at about 2:40 p.m. I Sri Swapan Kumar Das, AE & Station Manager, Bagmundih CCC along with 1. Asutosh Sharma, SAE(E), WBSEDCL 2. Narayan Chandra Debnath, HG TSH 3.
