North 24 Parganas (West Bengal) State Leader of Bharatiya Janata Party that on 02.11.18 at afternoon he attended an open meeting as a chief guest at Sarai Maidan under Balarampur PS, Dist-Purulia which was organised by local BJP Mandal Committee.

As such Shri Mukul Roy had committed offence U/S- 294/500/506 IPC. So you are directed to lodge FIR against Mukul Roy and arrange its investigation.
