Sub:- Lodging FIR against Sasanka Majhi S/O Prafulla Majhi for unauthorised use of Electricity by way of hooking up 135(i)(a) of Electricity Act 2003. (Amended in 2007).

Sir,

I Sri Amitava Choudhury, S/O Lt. Sajal Kr. Choudhury, DE & Station Manager, of Balarampur CCC, WBSEDCL do hereby lodge complaint against Sasanka Majhi, S/O Prafulla Majhi resides at vill-Singli, P.O-Nekre, P.S-Balarampur Dist- Purulia to the effect that received an information, that the aforesaid accused person is committing theft of electricity in his residence by way of direct hooking from the nearby LTOH line of WBSEDCL.

Acting upon such information yesterday on 31.10.2018 from 4.05 Pm to 4.55 Pm, I along with Sri Manab Kr. Majhi, SAE, Sri Aloke Kr. Modak HG. TSH and technical persons of M/s. Ajoy Kr. Ghosh (Entitled Agency of WBSEDCL) inspected the premises of Sasanka Majhi and held raid.

During raid and inspection it was detected that accused Sasanka Majhi is using electricity dishonestly by making direct hooking from the nearby LTOH line of WBSEDCL for running one $\frac{1}{2}$ HP (0.374 kW) Centrifugal Monoblock Pump Set for watering the homestead cultivating land for growing vegetables.

I prepared inspection report in presence of the accused and assessed the load as 0.374 kW. Details have been mentioned in the inspection report duly signed by the accused.

I directed Sri Aloke Kr. Modak, STG, TSH to disconnect the hooking line/arrangement from our LTOH line. Accordingly he disconnected the aforesaid hooking line/arrangement from LTOH line.
