Has committed theft of electricity U/S 135 (1/b) of The Electricity Act 2007.

Entered the premises of Hemipada Hembham, S/O Lt Jkii Hembham, Rithugana (Bordi) and inspect higher premises. During inspection theft of electricity was detected i.e. he/she was using electricity dishonestly by means of drawing illegal meter bypass of WBSEDC detected. U/S 135 (1/b)
