Respected Sir,

In producing here with arrested accused person namely Akshay Singh (age-55 yrs) S/O-Lt. Rashu Singh of vill. + P.O-Dhadka, P.S. Bandwan, Dist. Purulia along with seized Illicit Liquor (details of seized articles are mentioned in attached seizure list), I beg to submit that today at about 17:15 hrs during my evening mobile duty I received a credible source information over mobile that one person namely Akshay Singh S/O-Lt. Rashu Singh of vill. + P.O-Dhadka, P.S. Bandwan, Dist. Purulia making & selling illicit liquor in his house under Bandwan PS. Accordingly I, along with force namely C/1111 Ragda Mandi, C/859 Jitendra Nath Pandey both of Bandwan PS, Dist-Purulia left for Dhadka Village to work out the said source information vide Bandwan PS C.C No. 4264/18, Dtd-29/11/18. Then, at about 17:45 hrs I reached at Dhadka Village and found the said person was selling Illicit Liquor at the court yard in-front of his house under Bandwan PS. So, with the help of accompany force I searched thoroughly with proper decency and maintains all legal formalities and found that he is selling illicit liquor. Accordingly, I arrested him after preparing proper arrest memo as he committed offence U/S 46A(C) B.E. Act and supply one copy to him. Then, I seized (1) Illicit liquor approx 11 (eleven) liters in black plastic container (2) 04 pcs of plastic glasses (3) Cash Rs. 45/- (forty five rupees only) as sale proceed (details in seizure list) after preparing proper seizure list duly signed by the witnesses and labeled.

Under the above circumstances, I therefore pray before you that a cog case may kindly be started U/S 46A(C)B.E. Act 1909 against the arrested accused person namely Akshay Singh (age-55 yrs) S/O-Lt. Rashu Singh of vill. + P.O-Dhadka, P.S. Bandwan, Dist. Purulia and arrange for its investigation.
