I do hereby lodge complaint, empowered by enabling "The Electricity Act, 2003" subsequently electricity act-2007, to the effect that, KIRITI MUDI S/O LT. KESAR MUDI has consumer ID- 202218079 and meter number- 340069 of Vill- LATPADA, P.S- Barabazar, P.S- Barabazar, Dist- Purulia was enjoying electricity unauthorizedly by meter bypassing with the help of 2 core PVC cable and he has committed theft of electricity U/S 135(1)/B of the electricity (Amendment act-2007).

On 14.11.2018, I Sri ANSHUMAN MITRA, A.E. & S.M., BARABAZAR CCC, WBSEDCL along with

- (1) SAHEB SUTRADHAR, S.A.E(E), BARABAZAR CCC, WBSEDCL
- (2) MD QASIM ANSARI, O.E., BARABAZAR CCC, WBSEDCL

At About 04:10 P.M., entered into the premises of KIRITI MUDI S/O LT. KESAR MUDI of VIII- LATPADA, P.S- Barabazar, Dist- Purulia and inspected his premises.

During inspection, it was found that KIRITI MUDI S/O LT. KESAR MUDI of VIII- LATPADA, P.S- Barabazar, Dis- Purulia was enjoying electricity illegally by meter bypassing with the help of 2 core PVC cable in his premises at LATPADA having connected load 0.12 KVA. He is a consumer of WBSEDCL having consumer ID- 202218079 and meter number- 340069.

From the above arrangement he was using the following equipment:

Out of which I seized the following articles:

1. 01 No of energy meter with by passing arrangements(having sl. no. 340069)
