**Sub – Complaint against unauthorized extracting and removing of Minor Mineral.**

It has been reported that the bonafide holder of plot no – 110 of Mouza- Puijanga (Jl-170) Chunku Mahato, S/O- Gangadhar; Nayan Mahato, S/O Gangadhar and Manindranath Mahato, S/O Paban have extracted and removed 239250.00cft, 212350 Cft. And 288090 Cft. of Black Stone from three different blocks which is minor mineral from the plots of land mentioned without having any quarry permit, as required under the Law which is a Contravention of the provisions of Rule 3 of WB Minor Mineral concession Rules'2016. And thus they have committed theft of Total -739690 cft of Black Stone which is punishable U/S 379 of IPC, the measurement of such extraction was taken by Shri Bidyadhar Karmakar, Revenue Inspector, Latpada RI office under the Jurisdiction of BL&LRO, BZR.

Such unauthorized extraction and removal of minor minerals conducted by them is liable to be prosecuted under Rule 50 of the WBMM Concession Rule'2016, read wlt Section 21(2) of the Mines and Minerals (Regulation and development) Act'1957, and under Section 379 of IPC.

You are therefore requested to take necessary action against the offender for committing such offence in contravention with Rule 3 of WB Minor Mineral concession Rules'2016.

I am duly authorized by the Govt Of WB to lodge complaint u/s 22 of the Mines and Minerals (Regulation and development) Act'1957, in terms of notification no 89-CI/Gr-D/4M-30/88 dated 24/01/1991.
