found that he was enjoying electricity unauthorisely by
bypassing of energy meter by cutting incoming service
wire (Con ID - 202422641)

During inspection theft of electricity was found i.e.
was using electricity unauthorisely u/s 135(1)(b) was
detected. It was also found that he was using the
following electricity equipments

- ① One no. 100 watt bulb
- ② one no 20 watt CFL lamp
