I do hereby lodge a complaint empowered by enabling the Electricity act 2003 subsequently Electricity (Amendment) Act-2007 to the effect that Madam Karmakar S/O- Lt Krittibas Karmakar of Village- Dukhurdih, P.O- Dighi, P.S.- Boro, Dist - Purulia, has committed theft of Electricity U/S 135(1)(a) of the Electricity (Amendment) Act-2007.

On dated 28/11/2018 at about 08:15 PM, Sri Mrityunjay Mandal, Station Manager, Manbazar Customer Care Centre, WBSEDCL along with,

entered the premises of Madam Karmakar, S/O- Lt Krittibas Karmakar of Village- Dukhurdih, P.O- Dighi, P.S.- Boro, Dist - Purulia and inspected his/her premises, and found that he was enjoying electricity unauthorisely by direct hooking from WBSEDCL'S LT line.

During inspection, theft of electricity was found, i.e., he/she was using electricity dishonestly U/S 135(1)(a) was detected. It was also found that he/she was using the following electrical equipments -

- 1) Two nos 100 watt bulb
- 2) One nos 60 watt ceiling fan

out of which we seized the following -

The seizure list is prepared at the site and the accused person refused to sign in the seizure list. The inspection team left the above premises at about 08:30 PM on dated 28/11/2018. The accused person has committed an offence U/S 135(1)(a) of the Electricity (Amendment) Act-2007.
