Sir,

I, SI Bablu Ghosh of Hura PS do hereby lodge this FIR as suomotu against arrested accd persons (1) Nayan Sekh (32) S/o Lt. Harai Sekh of Vill- Bhadai, PS- Manteswar, Dist- Purba, Bardhaman and 2) Jahingir Sekh (29) S/o Jamir Sekh of Vill- Kusumgram, PS- Manteswar, Dist- Purba Bardhaman to the effect that today(19.11.18) during Evening mobile duty at around 20.25 hrs myself along with forces at Purulia-Bankura Road (NH60A) near Gurda More under Hura PS, found one Pick UP Van was running from Purulia and was headed to Bankura side with excessive speed and accordingly we intercepted the vehicle and found one person was on the driver's seat and another was beside him and there was none except them. In their presence I found that the vehicle bearing Rgn No. WB39B/0260(Mahindra Bolero Pick UP) was loaded with total seven cows of different size. On asked they revealed their identity as noted above (SL no 1 is the driver and SI No 2 is his assistant) but their identities could not be verified as they could not produce any document in respect of their address and age. On demand they could not produce any papers in respect of the vehicle as well as the seven Cows, and about the procurement of the cattle as well as the vehicle, they stated incoherently and from their statements there is every ground to believe that they have procured the vehicle and the cattle in any fraudulent means or by means of theft and was trying to conceal those and they are habituated offender in such offense. Moreover they were carrying those cattle in the vehicle in such a manner that those cattle were huddling together for the want of space. The above noted accd persons treated the cattle in such a manner so as subject those to unnecessary pain as they loaded those in such a vehicle which does not measure sufficiently either in height, length or breadth. Hence I seized those seven Cows and the vehicle bearing RGN No WB39B/0260(Mahindra Bolero Pick UP) from 20.45 hrs to 21.15 hrs from the possessions of the above noted accd persons under proper seizure list where the description of each cow is mentioned and after seizure I arrested them. It is to be noted that the place being remote no public witness could be made available and hence my accompanying police forces stood witnesses. After that I brought the arrested accd persons, seized vehicle and the seized cows to PS.

I, therefore pray that a case may kindly be started against the arrested accused (1) Nayan Sekh (32) S/o Lt. Harai Sekh of Vill- Bhadai, PS- Manteswar, Dist- Purba Bardhaman and 2) Jahingir Sekh (29) S/o Jamir Sekh of Vill- Kusumgram, PS- Manteswar, Dist- Purba Bardhaman U/S- 379/411/413/414 IPC and U/S- 11(1)(d)(e)(f) the prevention of cruelty to Animal Act 1960 and arrange its investigation.
