In producing here with one Jiten Murmu(22 yrs), S/O- Lt Manohar Murmu of village Shamukgoria, PS- Hura, Dist- Purulia along with following seized articles viz-

- 1) 18 Liters(Approx) of country spirit contained in a plastic container
- 2) 100 grams (Approx) NISHADAL,
- 3) Six pieces of plastic glass &
- 4) Sale proceed of Rs. 135/--

I SI Biswajit Sarkar of Hura P.S. do here by lodged a complaint against accd. namely Jiten Murmu(22 yrs), S/O- Lt Manohar Murmu of village Shamukgoria, PS- Hura, Dist-Purulia to the effect that today(29/11/18) at about 18.25 hrs in course of mobile duty I received a telephonic information from a reliable source that accd. Jiten Murmu(22 yrs), S/O-Lt Manohar Murmu of village Shamukgoria, PS- Hura, Dist- Purulia stocked country spirit illegally at his house at Shamukgoria village and selling the same to hike price for his personal gain. I informed the matter to O/C Hura PS and as per direction of O/C Hura PS myself along with C/574 Samar Dey, C/752 Durjodhan Sing Sarrdar, C/633 Dasharath Sing Mura all of Hura PS rushed to the spot for holding raid by Govt vehicle. At about 19.15 hrs myself along with force reached at Shamukgoria village and held raid in the house of Jiten Murmu(22 yrs), S/O- Lt Manohar Murmu of village Shamukgoria, PS- Hura, Dist- Purulia and found that Jiten Murmu was mixing the country spirit, contained in plastic Container, with some intoxicated substance(like white powder)having acrid smell which is likely to cause disability or death to human being, at his house at Shamukgoria village and seeing the police party liquor customer fled away but police party anyhow managed to apprehend accd Jiten Murmu ,and detained him. I asked him about the white powder like substance and accordingly, detained Jiten Murmu recognized it as "NISHADAL" (approx. 100gms contained in a plastic) an intoxicated substance having acrid smell which is likely to cause disability or death to human being. So I arrested the above mentioned accused person informing the ground of arrest and seized the above mentioned articles after preparing proper seizure list duly sign by accd person and available witnesses and also sealed and labeled the same.

Hence I therefore pray that a specific case may kindly be started under proper section of law against arrested accd. Jiten Murmu(22 yrs), S/O- Lt Manohar Murmu of village Shamukgoria, PS- Hura, Dist- Purulia and arrange for its investigation.
