In producing here with one Sahar Gope (32 Yrs.) S/o Hazari Gope of Vill- Madhuban, PS- Hura, Dist- Purulia along with following seized articles viz-

- 1) 20 Liters(Approx) of country spirit contained in a plastic container
- 2) 150 grams (Approx) NISHADAL,
- 3) Four pieces of plastic glass &
- 4) Sale proceed of Rs. 95/--

I ASI Jhantu Dalal of Hura P.S. do here by lodged a complaint against accd. namely Sahar Gope (32 Yrs.) S/o Hazari Gope of Vill- Madhuban, PS- Hura, Dist- Purulia to the effect that today(29/11/18) at about 18.45 hrs in course of mobile duty I received a telephonic information from a reliable source that accd. Sahar Gope (32 Yrs.) S/o Hazari Gope of Vill-Madhuban, PS- Hura, Dist- Purulia stocked country spirit illegally at his house at Madhuban village and selling the same to hike price for his personal gain. I informed the matter to O/C Hura PS and as per direction of O/C Hura PS myself along with C/118 Dijapada Mahato, C/924 Santosh Kr. Mahato and C/1494 Manas Mukherjee all of Hura PS rushed to the spot for holding raid by Govt vehicle. At about 19.25 hrs myself along with force reached at Madhuban village and held raid in the house of Sahar Gope (32 Yrs.) S/o Hazari Gope of Vill-Madhuban, PS- Hura, Dist- Purulia and found that Sahar Gope was mixing the country spirit, contained in plastic Container, with some intoxicated substance(like white powder)having acrid smell which is likely to cause disability or death to human being, at his house at Madhuban village and seeing the police party liquor customer fled away but police party anyhow managed to apprehend accd Sahar Gope, and detained him. I asked him about the white powder like substance and accordingly, detained Sahar Gope recognized it as "NISHADAL" (approx. 150 gms contained in a plastic) an intoxicated substance having acrid smell which is likely to cause disability or death to human being. So I arrested the above mentioned accused person informing the ground of arrest and seized the above mentioned articles after preparing proper seizure list duly sign by accd person and available witnesses and also sealed and labeled the same.

Hence I therefore pray that a specific case may kindly be started under proper section of law against arrested accd. Sahar Gope (32 Yrs.) S/o Hazari Gope of Vill- Madhuban, PS-Hura, Dist- Purulia and arrange for its investigation.
