Sir,

In producing herewith the arrested accused persons namely (1) Sunil kr. Mahato (32) s/o Kalipada Mahato (2) Atul Prasad Roy (47) S/O Lt. Tarapada Roy , (3) Bibhuti Mahato (52) S/O Lt. Falari Mahato of village - Kashidih, PS- Jhalda, Dist- Purulia, (4) Andip Chitrakar (24) @ Renga S/O Madhab Chitrakar of Dewandera, PS- Kotshila, Dist- Purulia before you, along with seized articles like board money amounting to (i) RS- 4600/- (Four thousand six hundred Rupees only) (ii) one Dabu height approx 11 ench, dice 12 (Twelve), (iv) Approx 5 fit/4 fit red colour raxin sheet, (v) One gas cylinder light containing approx 4 Kg. (LPG)

I beg to report that on 08/11/2018 at 16:05 hrs, received a credible secret information that one gambling with huge amount was going on at house of the Mangal Sing Mura S/O Dolu Sing Mura of village- Kashidih, PS, Jhalda Dist- Purulia. The matter was diaries vide Jhalda PS G.D.E No- 282 Dtd.- 08/11/2018 accordingly as per order of I/C Jhalda P.S I.S.I Rana Bhakat along with (1) ASI Mrimoy Chowdhury, (2) C/538 Dayamoy Mahato (3) C/386 Sibendu Shina, (4) HG/1634 Gopal Majhi vide C.C No- 3330/18 in vehicle No- WB-68L/7465 to work out the information. At about 17:45 hrs. We reached near house of the Mangal Sing Mura and very slowly and cautiously approached towards the door of the house, where the gambling was reportedly going on, we over heard the talking of persons present there and within a few moment it was clear that the persons present there were continuing gaming with Dabu and dice in exchange of money causing wrongful loss to one and wrongful gain to another. After that I asked my associate staffs to cordon the place and within a moment the place was cordoned by Police party. We disclosed our identity and requested them to search raid party accordingly the persons searched ourselves and found nothing except wearing apparels and Mobile Phones. After that we asked their identity and the persons disclosed their name and address as noted above. It was found that a huge amount of currency note of different denomination were kept on gaming board (Approx 5 fit/4 fit red colour raxin sheet) and playing Dabu dice were also found. On demand the persons clearly confessed that (i) Sambhu Gorai S/O Not known of Jhalda School more, PS Jhalda , Dist- Purulia (ii) Dhiren Gorain S/O Not known of Bonga Bari, PS- Kot-shila, Dist- Purulia, A/P Jhalda School More and house owner Mangal Sing Mura and all of them were doing gambling with Dabu dice in exchange of cash for wrongful loss to one and wrongful gain to another with full knowledge. We searched for the public witnesses but none was available. At about 18:15 hrs. we searched their persons and found some personal belonging, cash. All articles were seized under proper seizure list duly signed by our staff and supplying copy to them. After that in presence of persons noted above the board money of (i) RS- 4600/- (Four thousand six hundred Rupees only) (ii) one Dabu height approx 11 ench, dice 12 (Twelve), (iv) Approx 5 fit/4 fit red colour raxin sheet, (v) One gas cylinder light containing approx 4 Kg. (LPG) with different denomination, were seized for the gaming board in between 18:35 hrs. to 18:55 hrs. Under proper seizure list which is duly signed by the accused also.

As such for committing offence punishable u/s- 3 & 4 of W.B.G & P.C Act all the above noted 04 (four) accused persons were arrested, issuing arrest memo

From the statement of accused persons it was clear that the gaming was going on under guidance and full of knowledge of the house owner of village Kashidih , P.S- Jhalda, Dist. - Purulia.

Therefore I pray before you that one specific case may kindly be start under proper section of law against the above noted accused persons along with house owner Mangal Sing Mura S/O Dolu Sing Mura of village - Kashidih, PS- Jhalda, Dist- Purulia and arrange its investigation.
