with huge amount was going on at house of the Mangal Sing Mura S/O Dolu Sing Mura of village- Kashidih, PS. Jhalda Dist- Purulia. The matter was diaries vide Jhalda PS G.D.E No- 282 Dtd.- 08/11/2018 accordingly as per order of I/C Jhalda P.S.I.S.I. We reached near house of the Mangal Sing Mura and very slowly and cautiously approached towards the door of the house, where the gambling was reportedly going on, we over heard the talking of persons present there and within a few moment it was clear that the persons present there gain to another. After that I asked my associate staffs to cordon the place and within a moment the place was cordoned by Police party. We disclosed our identity and requested them to search raid party accordingly the and playing Dabu dice were also found. On demand the persons clearly confessed that (i) Sambhu Gorai S/O Not known of Jhalda School more, PS Jhalda , Dist- Purulia (ii) Dhiren Gorain S/O Not known of Bonga Bari, Ps-Korshila, Dist-Purulia, A/P Jhalda School More and house owner Mangal Sing Mura and all of them were doing knowledge. We searched for the public witnesses but none was available. At about 18:15 hrs. we searched their persons and found some personal belonging, cash. All articles were seized under proper seizure list duly signed by our staff and supplying copy to them. After that in presence of persons noted above the board money of (i) RS-4600/- (Four thousand six hundred Rupees only) (ii) one Dabu height approx 11 ench, dice 12 (Twelve), (iv) Approx 5 fit/4 fit red colour raxin sheet, (v) One gas cylinder light containing approx 4 Kg. (LPG) with different denomination, were seized for the gaming board in between 18:35 hrs. to 18:55 hrs. Under proper seizure list
