



Most respectfully begs to submit as follows:-

- 1. That the Complainant is a resident of Village- P.O.-Brajapur, P.S.Jhalda, Dist. Purulia and within the jurisdiction of your Honour's Court.
- 2. That on 4-7-2013 marriage was solemnised in between the accused No.1 Dilip Kumar Gorain and the Complainant Pabita Gorain according to Hindu rites and custom prevailent in their community.
- 3. That at the time of marriage Naresh Sao, the father of the complainant had to pay considerable amount of Rs.85,000/- as dowry money. The said sum of Rs.85,000/- was collected by the father of the complainant from his relations and others. That apart the cash money of Rs.85,000/- utensils of Rs.10,000/- and furniture amounting to Rs.20,000/- had been given by the father of the Complainant.
