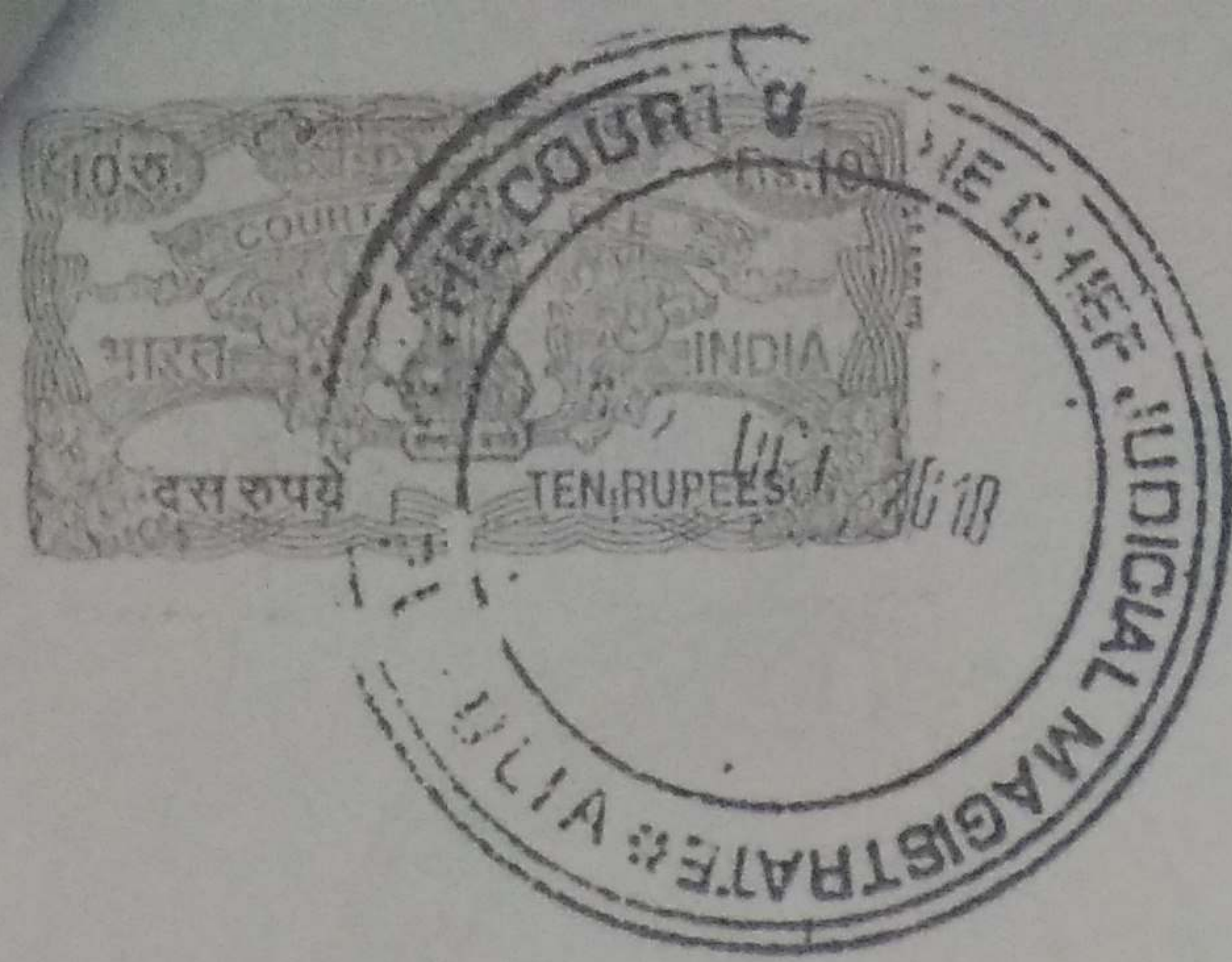

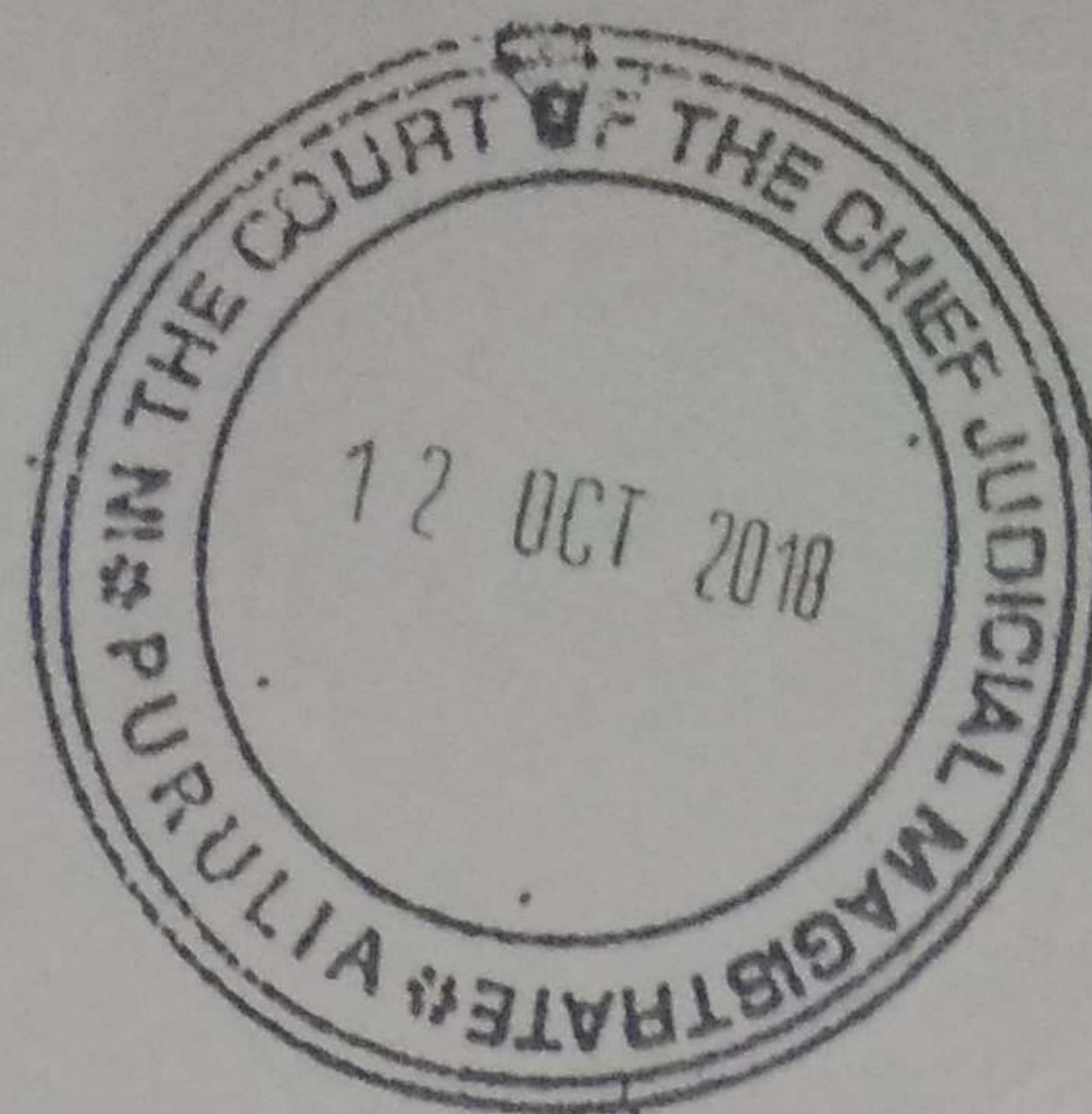

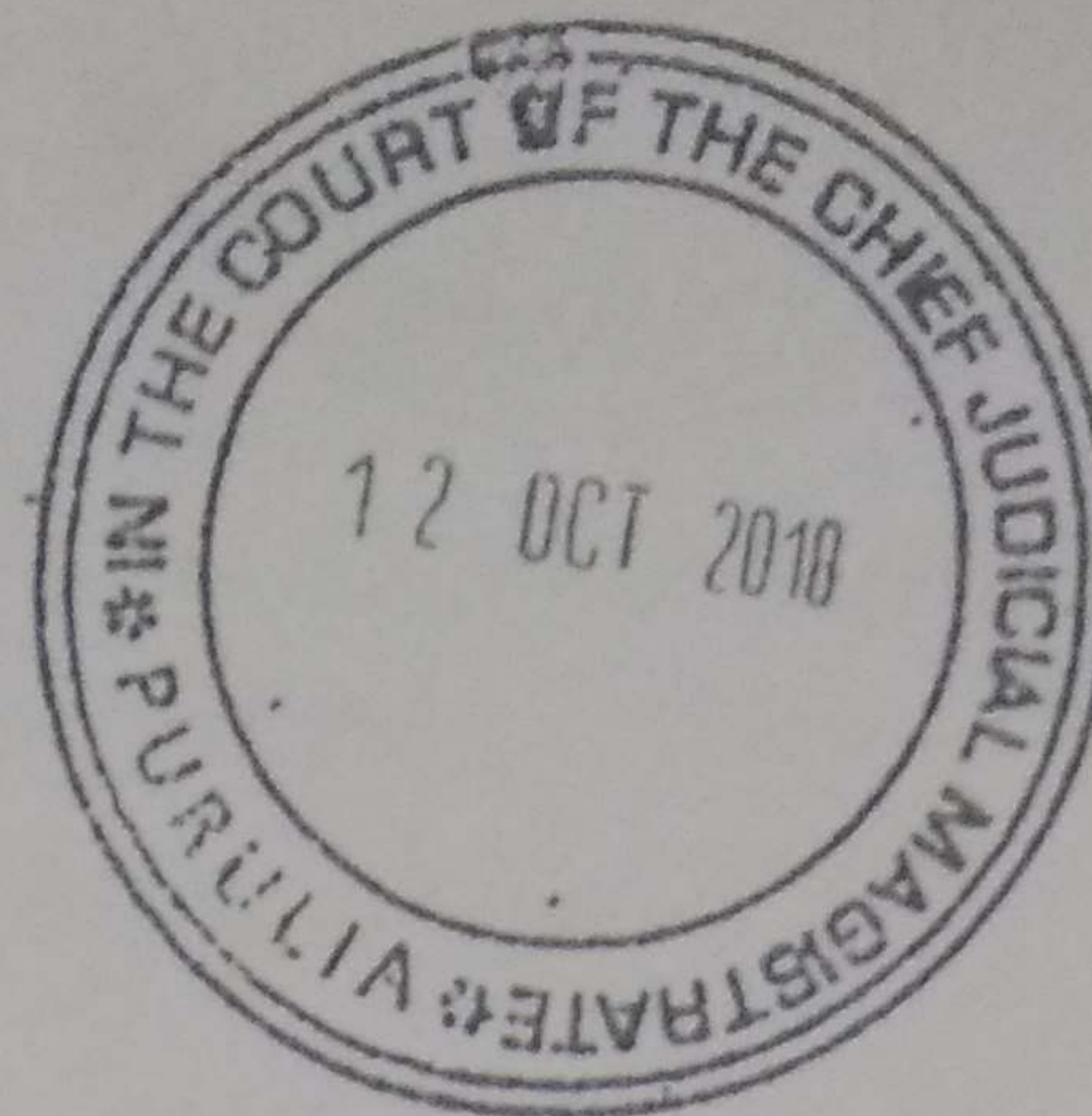

Most respectfully begs to submit as follows:-

1. That the Complainant is a resident of Village- P.O.-Brajapur, P.S.Jhalda, Dist.Purulia and within the jurisdiction of your Honour's Court.
2. That on 4-7-2013 marriage was solemnised in between the accused No.1 Dilip Kumar Gorain and the Complainant Pabita Gorain according to Hindu rites and custom prevalent in their community.
3. That at the time of marriage Naresh Sao, the father of the complainant had to pay considerable amount of Rs.85,000/- as dowry money. The said sum of Rs.85,000/- was collected by the father of the complainant from his relations and others. That apart the cash money of Rs.85,000/- utensils of Rs.10,000/- and furniture amounting to Rs.20,000/- had been given by the father of the Complainant.
4. That out of total demand of Rs.85,000/- in cash, the father of the complainant could pay Rs.10,000/- to Bhagtu Gorain, the father of the accused No.1.
5. That after marriage the complainant had been to house of her husband Dilip Kumar Gorain.
6. That the inmates of the house of the accused Dilip Kumar Gorain used to beat and ~~keep~~ also kept starving her.
7. That the accused Nos.1 to 9 are living within P.S.Jhalda and the accused Nos.10 and 11 are living at Village-Daria, P.S. Ichag.

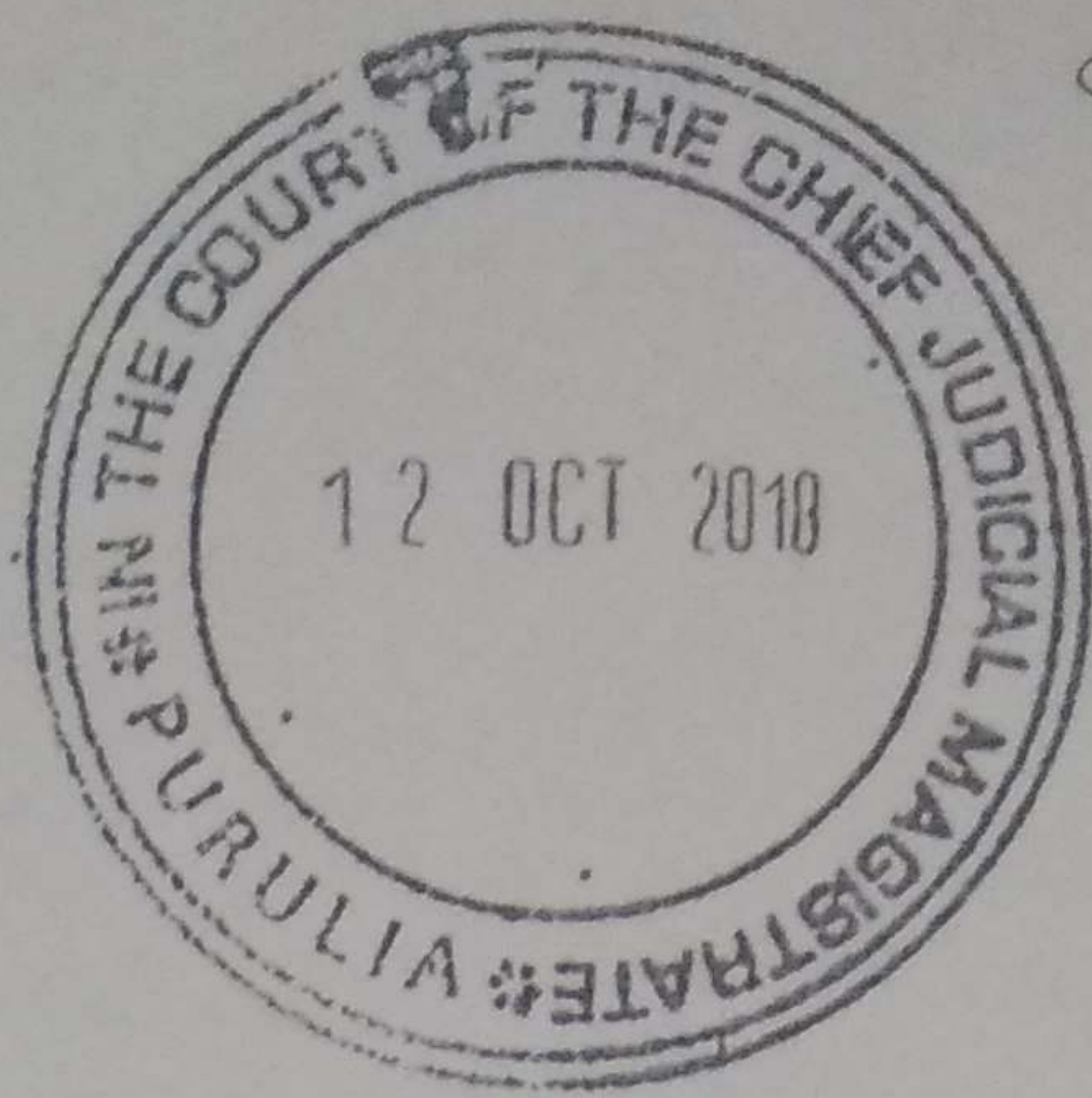
