2. That the state of West Bengal has given Patta to the grand father of the complainant of Mouza ,Kalyanpur vide Patta Case No. 37/1975 in R.S. Plot No. 193 Area 1 acre and have give spot possession.
3. That the grand father of the complainant possessed the said land by growing seasonal crops there in till his death and after his demise the father of the complainant came into possession and possess the same in various ways and in the L.R.Operation the said land has been recorded in the name of the Grand father of the complainant in L.R. Khatian No. 129.

4. That this year father of the complainant cultivate/- produce Biri ,Kolai on the said land and accordingly the complainant on 18/7/2018 went to see the sapling on the aforesaid land and on that very day the above named accused persons in furtherance of their common intention illegally entered in the said land and forcibly spoiled/destroy the saplings which the father of the complainant cultivate on the the said land on being protest by the complainant they assaulted to complainant by fist and blows then the complainant in order to save himself ran away but the accouse persons in order to kill the complainant chase him and tried to assault the complainant on the head by lathi but in vain as the neighbouring people arrived and save the complainant from the clutches of the accused - persons.

5. That there after the complaint with the assistance of the near relatives went to Joypur Police Station and lodged complain against the accused persons on that very day though the O.C. of the said P.S. assured the complainant that legal action will be taken against the accouse persons

Persons but no action has yet been taken.

6. That the complainant is a helpless poor person having no source of income and not a position to continue the case at his own cost.
7. That the matter is very serious in nature and accordingly police investigation is required.
8. That the complainant informed the matter to the Superintendent of Police Purulia, on 20/9/2018 but no action has yet been taken as such the complainant in filing this petition before your honour's Court.

For the circumstances it is prayed that your Honour may be pleased to send this petition of complainant to the officer -in-Charge of Joypur police Station treating the same as F.I.R. under Sec. 156 (3) of the Cr.P.C. for investigation.
