and inspected his/her premises. During the inspection theft of electricity was detected i.e. by passing the energy meter i.e. U/S 135(i) was detected. The details of passing the arrangement was damage: installation of the incoming wire and top 2 (two) piece of wire by which electricity directly flow to his house without energy registration in WBSEDCL energy meter.

From the above by-passing system he/she uses the following electrical equipments.

One electric heater and PVC two core.

Out of which I seized the following.

Two core PVC cable approx length 10 feet.
