Most respectfully begs to state as follows:-

1. That the petitioner Rinku Roy Mahato is the legally married wife of opp. party no.1 and their marriage has been solemnised on 5.05.2018 at Ray Baghini Mandir under Purulia(R) P.S. and all the formalities has been observed in presence of all god as well as in presence of the friends and relatives of the parties.

Here to it mentioned that, since more than 7 (seven) years there has been love affair is between the parties and ultimately they decided to marry each other and as the family members of the opp. party had no consent as such the opp. party took all attempt to bring the petitioner at Ray Baghini Mandir and performed all the formalities of marriage and since after marriage both the parties enjoying happy marital life ^{upto this date} since ~~upto this~~ one month from the date of marriage.

2. That accused no.2 is the husband, accused no.3 is the father in law, accused no.4 is the mother in law, accused no.5 is the Elanour (brother in law) accused no.6 is the wife of accused no.4.

3. That since after one month from the date of marriage dispute cropped up relating to give legal status to the petitioner as the petitioner put pressure to the accused no.1 and other to registered the marriage before the marriage authority but the opp.party/accused applied various tricks to lags the time for his own accord and ultimately petitioner informed the matter before the Magistrate P.S. and on 18.6.2018 by the intervention of the police with help of village people a violent compromised held between the petitioner and opp.party/accused where accused gave assurance to keep the petitioner well but after few days opp.party/accused alongwith other family members started physical as well as mental torture upon the petitioner which was unbearable to the petitioner.

4. That, being no other alternative petitioner came back to her father's house on 15.06.2018 and since then petitioner residing at her father's house at Vill. Balayewatipur under P.S.Mandazar, Dist.Purulia without any connection with the accused no.1.

5. That, recently in the month of August, petitioner came to know that accused no.1 started to develop physical relationship with another girl namely Namal Mahato o/o Keshab Mahato of Vill.Mallikdanga, P.O.Ganakhuta, P.O.Raikhandh, Dist.Bankura, which is very much illegal and injustice to the petitioner.

6. That, the petitioner is a deserted lady forced to reside at her parents house by the accused without

providing any food, cloths as well medicine and the petitioner passed her days by the mercy of the villagers and petitioner have no capacity to lodged the case and consent the same by her own capacity as much delay, u/s, 150(3) Cr.P.C. is required.

7. That I subsequently petitioner engaged her sister informed the matter before the Mahabar P.S. but as the P.S. compromised the matter previously as such denied to accept the written complaint and your petitioner informed the matter to the S.D. through written complaint out of no good.

It is therefore prayed that your honour may graciously be pleased to direct the police of Mahabar P.S. to treat this petitioner as P.I.D. and to cause investigation in respect of the alleged incident for the sake of justice.
