

The above named Petitioner / Complainant;

Most respectfully begs to state as follows:

1. That, Your Petitioner / Complainant is the owner of the landed properties situated within the District - Purulia, Mouza - Pathar Mahara, J.L. No. - 145, portion of R.S.L.R. Plot No. 691 with specific boundary; by dint of his purchased deed.
2. That, the Complainant and his brother Bijoy Krishna Karmakar are the owners and in possession over the portion of R.S.L.R. Plot Nos. 691 with specific boundary within Mouza Pathar Mahara by

the power of a Registered purchased deed being No. 314 for the year 2001, executed by its rightful owner, wherein the accused No. 1 is the witness in the said purchased deed. Since purchase the Complainant and his brother named above are in exclusive, uninterrupted and continuous possession over their purchased properties unconcern of other to the knowledge of everyone in the locality. The Complainant and his brother named above have their valid right, title, interest and possession over the same. Whereas the accused persons have no right, title, interest and possession over the same.

3. That, the portion of land of the Petitioner/ Complainant within R.S./L.R. Plot No. 691 situated besides the Manbazar - Bandwan road. After obtaining necessary permission from the Bisri Gram Panchayat the Complainant started digging earth in his specific portion of land within R.S./L.R. Plot No. 691, for the purpose of construction of his house over the same.
  4. That, on 22.07.2018 morning at about 9 A.M. while the Complainant / Your Petitioner was engaged of cutting earth over his specific portion of land within R.S./L.R. Plot No. 691, the accused persons with their common intention along with some hooligans enter into the land of the petitioner armed with lathi, tangi, iron rod etc, and used filthy languages towards the petitioner and also given threat to your petitioner not to dig earth over the portion of R.S./L.R. Plot No. 691; if he tried to do so he will be killed by the hands of the accused persons.
  5. That, the Complainant requested them that the property belongs to his brother and himself as they purchased the same from its rightful owners by way of a Registered Purchased Deeds and the accused No: 1 is also the witness in the said deed. But the accused persons are adamant and became enraged did not allow the petitioner to cut earth over his portion of land in R.S./L.R. Plot No. 691, for the purpose of construction house over the same.
  6. That, the Complainant protested the illegal act on be part of the accused persons, as a result the accused persons started mercilessly assaulting him with fust and blows for which the Complainant / Your Petitioner sustained injuries on his person.
  7. That, the witness Nos. 2 and 3 have their landed properties nearby the property of the complainant. Witness Nos. 2 and 3 along with witness Nos. 4 and 5 were busy in their cultivation work in their respective landed properties nearby the property of the complainant at the relevant time.

8. That, the Complainant was started soughing with dire consequence, hearing the noise the witness Nos. 2 to 5 rushed to the very spot to save the Complainant and the accused persons with their engaged hooligans fled away from the very spot.
9. That, after the incident on the same day, that is on 22.07.2018, the Complainant went to the local P.S. to lodge complaint against the accused persons. But the officer denies to receive any complaint against the accused persons as the accused persons are the moneyed men.
10. That, as the officer of Marchizar P.S. did not take any steps against the accused persons, the Complainant made complaint to the S.P. of Purulia on 25.07.2018; but until now no step has yet been taken by the Police.
11. That, having no other alternative the Complainant knocks the door of the Lt. Court of Law for his relief.
12. That, the Complainant is a marginal cultivator and living hand to mouth, it is hardly possible for him, to prosecute the case with his private capacity.

Hence the Complainant prays that Your Honour may graciously be pleased to send this Complaint to the O.C. of Mambazar P.S. with a direction to treat the same as F.I.R. and start the case Under Section 341/323/506/341 I.P. Code against the accused persons. Otherwise there will be serious miscarriage of justice.
