I do hereby lodge a complaint empowered by enabling the Electricity act 2003 subsequently Electricity (Amendment) Act-2007 to the effect that Sri Sudhir Mahato S/O- Mariram Mahato of Village- Putkadih, P.O- Majhira, P.S- Manbazar, Dist - Purulia, has committed theft of Electricity U/S 135(1)(a) of the Electricity (Amendment) Act-2007.

On dated 15.11.2018 at about 03:30 PM, Sri Mrityunjay Mandal, Station Manager, Manbazar Customer Care Centre, WBSEDCL along with,
