I do hereby lodge a complaint empowered by enabling the Electricity act 2003 subsequently Electricity (Amendment) Act-2007 to the effect that Sri Sudhir Mahato, Dist. Purulia S/O - Lalit Kumar Mahato of Village - Putkachik, P.O - Majhihira, P.S. - Manbazar, Dist - Purulia, has committed theft of Electricity U/S 135(1)(a) of the Electricity (Amendment) Act-2007.

On dated 15.11.2018 at about 05:30 AM, Sri Mrityunjay Mondal, Station Manager, Manbazar Customer Care Centre, WBSEOCI along with,

Entered the premises of Sri Sudhir Mahato, W.O - Lalit Kumar Mahato of Village - Putkachik, P.O - Majhihira, P.S. - Manbazar, Dist - Purulia and inspected his/her premises and found that he was enjoying electricity unauthorisedly by direct hooking from WBSEOCI's 17 line.

During inspection, theft of electricity was found, i.e., he/she was using electricity dishonestly U/S 135(1)(a) was detected. It was also found that he/she was using the following electrical equipments -
