- 2) That being the legal owner of the land bearing R.S. Khation No. 334 of Mouza- Hatilada Gurutupa, J.L. part No. 1299, 1417, 1418, 1419, 1457 and 1352, your petitioner have been possessing and growing paddy crops, etc, on that lands since long peacefully and without any disturbance .
- 3) That as usual, this year also your petitioner planted paddy on that lands and was making arrange etc. for peaping the matured paddy crops within the 1st week of August of this year.
- 4) That on 14/8/2018 and lastly 24/8/2018 at about -8 A.M. while your petitioner was about to his paddy lands , all the accused persons along with some hired goondas with sharp Aye, lathi, and tarwal etc, and separetly Axe, Kodal, Iron rod, etc forcibely entered in to the lands belong to your petitioner and fordibley started toreap the harvest .
- 5) That while your petitioner was raising objection and shouting for help, all the accused persons pushed him out from the lands and threatened to kill him if he remain there any more .
- 6) That on observing the furious and violent moods of the miscreants, nobody dired to help your petitioner and he was helpless and compelled to see that the paddy crops of his own were being looted by the accused persons within one
