I do hereby lodge a complaint empowered by enabling the Electricity act 2003 subsequently Electricity (Amendment) Act-2007 to the effect that Aditya Mahato S/O Gopal Mahato of Village- Tekadik, P.O- Bishri, P.S- Manbazar, Dist - Purulia, has committed theft of Electricity U/S 135(1)(a) of the Electricity (Amendment) Act-2007.

On dated 28/11/2018 at about 07:30 M I, Sri Mrityunjay Mandal, Station Manager, Manbazar Customer Care Centre, WBSEDCL along with,

During inspection, theft of electricity was found, i.e., he/she was using electricity dishonestly U/S 135(1)(a) was detected. It was also found that he/she was using the following electrical equipments -
