I do hereby lodge a complaint empowered by enabling the Electricity Act 2003 subsequently Electricity (Amendment) Act-2007 to the effect that Aditya Mahato, S/O Gopal Mahato of Village- Tchadik, P.O- Bishri, P.S. Manbazar, Dist - Purulia, has committed theft of Electricity U/S 135(1)(a) of the Electricity (Amendment) Act-2007.
