In producing herewith one accd. Person namely Dinesh Dey @ Bhadhu (34) S/O- Lt. Manmotho Dey of Vill-Hijuli (Kabi Para), PS-Neturia, District-Purulia with seizure of (1) 07 pcs. Sealed bottles of Dil Se Country Sprit containing 375 ml each (2) 05 pcs. Sealed bottles of Dil Se Country Sprit containing 600 ml each and (3) 10 pcs. Sealed bottles of Dil Khush Country Sprit containing 600 ml each which were seized under proper seizure list.

I beg to submit that today (28.11.18) in between 20.05 hrs to 21.15 hrs. a raid was conducted at Parbelia Bazar in the hotel "styled as Bhai - Bhai Hindu Hotel" of Dinesh Dey @ Bhadhu (34) S/O- Lt. Manmotho Dey of Vill- Hijuli (Kabi Para), PS-Neturia, District- Purulia on acting of a secret source information against illegal stock and selling of liquor of the above noted anticipated place and found that the above noted person was keeping / selling liquor which were kept in his house, on demand Dinesh Dey @ Bhadhu failed to produce any valid documentary authority in respect of selling of liquor as well as nobody turned up to produce any valid documents . As such he committed offence u/s 46 A(c) B.E. Act and he was arrested U/S-67 BE Act and also (1) 07 pcs. Sealed bottles of Dil Se Country Sprit containing 375 ml each (2) 05 pcs. Sealed bottles of Dil Se Country Sprit containing 600 ml each and (3) 10 pcs. Sealed bottles of Dil Khush Country Sprit containing 600 ml which were seized under proper seizure list duly signed by witnesses and labeled at the time of arrest. During arrest the ground of arrest was duly notified, issued arrest memo u/s 50 Cr.P.C. and handed a copy of the same to arrestee.

The arrested accd. namely Dinesh Dey @ Bhadhu (34) S/O- Lt. Manmotho Dey of Vill- Hijuli (Kabi Para), PS-Neturia, District- Purulia has committed offence u/s 46 A(c) B.E. Act, 1909 for unauthorized possession and sale of liquor.

It may note here that during raid 1. C/382 Bipad Taran Chatterjee and 2. JC/702 Pratap. Narayan Das both of Neturia PS accompanied me.

Under the fact and circumstances I therefore pray that a specific case may kindly be started against Chatur Bauri (58) S/O- Lt. Akul Bauri of Vill- Neturia, PS-Neturia, District- Purulia under proper section of law.
