I, ASI Bikash Ch. Patra, in producing herewith one arrested accused namely one Subhan Ansary (22) S/O- Jakir Ansary of Dumurhir, PS- Neturia, Dist- Purulia with one improvised pipe gun (iron made) approx 26 cm in length, steel colour batt, barrel, trigger, firing pin, hammer etc. along with 02 round live cartridge (marked as BMM KF) to the effect that today on 29/11/18 at 21:05 hrs received credible source information before duty officer that one person with arms moving suspiciously at Jhanka More with a ill motive for committing any serious crime. Accordingly duty officer diarised the matter vide Neturia PS GDE No- 1327 dated: 29/11/18 and informed to O/C Neturia PS accordingly, as per kind order of O/C Neturia PS myself along with C/242 Arun Kuamr, C/470 Somnath Nag & C/278 Ashok Chandra who were engaged in evening mobile duty left for Jhanka More to work out the information. We reached at Jhanka more at 21:45 hrs and got down from Government vehicle bearing Reg. No- WB 56C 8993 and proceed towards the water tank. We found that seeing police party one person tried to fled away from there and after a hot chased we managed to apprehend him. On being asked he disclosed his identity as noted above. Searched the above noted persons very carefully and recovered one improvised pipe gun (iron made) approx 26 cm in length, steel colour batt, barrel, trigger, firing pin, hammer etc. along with 02 round live cartridge (marked as BMM KF) from his right side pocket of burmuda pant which were concealed and stated incoherent statement in respect of his presence at the area at night. There was every reasonable believe that the accused had came down in the area with a view to commit crime by using the illegal fire arm and there by liable to be prosecuted. On demand he failed to produce any valid documents/license in respect of the said arm & ammunitions. Then I seized and labeled one improvised pipe gun (iron made) along with 02 round live cartridge (marked as BMM KF) from his possession under proper seizure list duly signed by the accused person and witnesses between 22:15 hrs to 22:45 hrs accordingly at 22:55 hrs I arrested the above noted accused person issuing arrest memo after maintaining all formalities of arresting rule. During seizure, I have tried to procure public witnesses to put down signature but public witness is not present there at dead hours of night.

Under such circumstance it is reasonably believe that arrested accused person have committed a serious offence and he is liable for an offence personable U/S- 25/27 arms act.

Therefore, I pray that a specific case may kindly be registered against one Subhan Ansary (22) S/O-Jakir Ansary of Dumurhir, PS- Neturia, Dist- Purulia under proper section of law.
