Sir,

With due respect I beg to state that on 02.11.2018 at 21.45 hrs I ASI Falguni Sarkar of Para PS along with C/26 Kripasindhu Deogharia, C/1405 Sital Chandra Karak & PD/180 Dilip Kr. Das along with Govt. vehicle bearing registration No. WB-56C / 0015 left PS for performing night mobile duty. On 03.11.18 at 02:00 hrs when we were moving towards Dubra from Rukni more our vehicle was passing through a narrow bridge near Dubra Samsan Kali mandir on Raghunathpur - Chandankeyari road at that time a Dumper bearing Registration No. JH05AQ/0813 rashly and negligently coming from opposite side dashed the Govt. vehicle WB- 56C / 0015. Resulting which the said Govt. vehicle capsized on the bridge and the vehicle got damaged totally. I ASI Falguni Sarkar, C/26 Kripasindhu Deogharia, C/1405 Sital Chandra Karak & PD/180 Dilip Kr. Das received serious bleeding injury. After receiving the information of this incident other officer and force reached to the spot and admitted all of us at Para BPHC. Later on PD-180 Dilip Kumar Das shifted to Purulia Sadar Hospital for better treatment.

Under the above circumstance I pray before you for starting a case under proper section of law against the driver of vehicle No. JH05AQ/0813(Dumper).
