During inspection theft of Electricity was found, i.e. he/she was using Electricity dishonestly by direct tapping from service cable of inside of any meter

Supply i.e. U/S 135 was detected.

From the above system he/she was using the following Electrical equipments i.e.

- ① BULB - 100 watt - 5nos
- ② TV - 120 watt -
- ③ LED BULB - 20 watt - 5nos.
