the energy meter i.e. U/S 135(I) (a) was detected. The details of passing the arrangement was damage
installation of the incoming wire and top 2 (two) piece of wire by which electricity directly flow to his
house without energy registration in WBSECL energy meter.

From the above by-passing system he/she uses the following electrical equipments.

(i) Lamp- 03 (Three) and cable 100 W etc

Out of which I seized the following

(i) Flexible cable 02 (two) Core - 06 (Six) Meter approx.
