Sir,


In producing here with one arrested accused person namely Aktar Ansari (30) s/o Muksed Ansari of Selam, Ramamati, PS Joypur, Dist Purulia along with seizure list and seized articles (i) One Pickup van bearing Registration No JH10AP/3136 (ii) 10 (ten) animals (bull ox).

I do hereby submit a written complaint to the fact that today on 09/11/18 I along with force have been detailed for night patrolling duty on Purulia- Ranchi road vide CC No 2897/18 and GDE NO- 366 dt 09/11/18 with Govt vehicle Registration No WB 26C/5298. Accordingly, myself along with force have been given departure at 17.15hrs and we proceeded to our duty on Purulia- Ranchi road and when we reached beside Tata motors show room near Lagda Village at about 18.05 hrs, found one Pickup van bearing Registration No JH10AP/3136 was coming from Ranchi side towards Purulia side and we suspected that the said vehicle was loaded with animals. On being asked the accused driver noted above of the said vehicle cannot gave any satisfactory answer neither he can produced any valid documents for such type of transportation of the animals. Hence we detained the said vehicle beside the pitch road near Lagda village with proper signal and on searching found the vehicle is loaded with 10(ten) animals (Bull ox) with a insufficient space, length and height and the said animals are suffering from pain due to carrying such type of vehicle and insufficient space of the vehicle. He also stated that he along with one Maimuddin Ansari of Tokoria Vilage, PS- Barabazar and owner of the vehicle namely Juman Ansari of Garafusta, PS Purulia (M) loaded the said animals with intend to sale the animals to another place to make profit by illegal manner in view of clandestine business. He also stated that they were habitually involved such type of clandestine business. Myself held an enquiry and during enquiry nobody turned up before me with proper demand of the animals or vehicle and it came to light that there is every reasonable ground to believe that the said animals were procured by illegal manner or stolen property and they are habitually dealing in stolen property and assisting in concealment of stolen property with intend to make profit by such type of clandestine business habitually. Hence I seized the vehicle bearing Registration No JH10AP/3136 (ii) 10 (ten) animals (bull ox) with proper seizure list and arrested the involved driver. I have issued memo of arrest maintaining all legal formalities. Informed to relatives of arrested accused person regarding ground of arrest. Seizure arrest was done in between 19.05 hrs and 19.55 hrs. After unloaded the vehicle myself along with force brought the said vehicle and the animals at PS compound and kept with proper guard and also arranged sufficient water and straw etc. to the animals.

Under the above facts and circumstances, I pray before you that kindly lodge a specific case against the arrested driver and involved accused and involved owner of the vehicle.
