Sir,

In producing herewith one arrested accused persons namely (i) Nasiruddin Ansari (58 yrs) S/o - Lt Abdul Majid Ansari of Chirkha PS - Purulia (M), Dist - Purulia with memo of arrest, seizure list and a seized black colour Hero Passion pro Motorcycle bearing Reg. No. JH 05BS/6341 Engine No. HA10END GA10020 and Chassis No. tempering I beg to lodge this complaint against the above named arrested accused person to the fact that, today (29.11.18) at 10.35 hrs you as O/C of the PS had received a credible source information vide Purulia (M) PS G.D.E No. 1171 Dt 29.11.18 that the above named professional motorcycle lifter was coming towards Purulia Township from Chas road side riding on a black colour Hero Passion pro Motorcycle bearing Reg. No. JH 05BS/6341 in order to disposal of the theft motorcycle at Purulia Township in the open broad day light and as per your order I with ASI Basudeb Ojha, ASI Janardan Kumar , C/1471 Sankar Ruhidas C/1413 Kanaulal Mandal, JC/950 Goutam Betal left for Imundih more near Pandey Hotel area on Purulia - Ranchi Road along with the source to work out the information vide Purulia (M) PS G.D.E No. 1172 Dt 29.11.18 & C.C No. 3083/18 and Govt vehicle bearing No-WB56B/5363. Reached Imundih more near Pandey Hotel area at 11.45 hrs on Purulia - Ranchi Road and directed the police vehicle to park it near Pandey Hotel until further order. We laid on Naka checking & awaiting arrival of the targeted motorcycle lifter. At 14:45 hrs, a black coloured motorcycle coming towards Purulia side from Chas road side and the source identified the rider driver as one Nasiruddin Ansari S/o - Lt Abdul Majid Ansari of Chirkha PS - Purulia (M), Dist - Purulia. At once, we suddenly reached the middle of the road and before the motorcyclist could take a turn to flee away towards Chas road we cordon him. Seeing us, the motorcycle rider started up and made an attempt to run away leaving behind the motorcycle but we at once intercepted him with the motorcycle before he could run away. By this time two (02) passerby coming from Imundih more side area reached that spot and being requested, both of them namely (i) Binod Dubey S/o - Lt Anil Dubey & (ii) Arjun Kumar Dubey S/o - Lt. Santosh Kumar Dubey both of village Shubdih , PS - Purulia (M), Dist - Purulia, agreed to act as witness of seizure of the motorcycle in question. The intercepted person on interrogation made incoherent statement in r/o his identity and about the registration certificate, Insurance certificate etc and the name of its owner & and failed to produce any document in support of the said motor cycle. After repeated interrogation, he admitted that the motorcycle was a stolen one procured by him by committing theft from Jharkhand side . He also stated that he changed the Number plate, used to tamper both the Engine and Chassis No in order to make those illegible in order to avoided identification of the original motorcycle. He also confessed before all of us including the witnesses present there that, he is professional motorcycle lifter and have stolen away many motorcycles from Jharkhand side area round a year and had sold those stolen motorcycle one after another to different customers affixing similar fictitious number plate with fictitious registration Number surreptitiously and earned a lot. He also confessed that he had



assured to manufacture document in r/o the sold stolen motorcycle and handed over the purchaser shortly. He agreed that he would be able to identify the purchaser of such stolen motorcycle, their residential home and would be able to identify the stolen motorcycle.

I, as such seized the black colour Hero Passion pro Motorcycle bearing Reg. No. JH 05BS/6341 on the rear number plate having Engine No.HA10END GA10020 and Chassis No. temporing under a seizure list prepared by me on the spot, from 15.05 hrs to 15.25 hrs in presence of those two (02) public witnesses named above under their signature as per provision of section 102 Cr. P.C and arrested him the intercepted person as above as disclose by him subsequently after preparing arrest Memo and Inspection Memo informed him regarding the ground of arrest. I arranged to send information for intimation to the house inmate of the arrested accused person at village Chirka through special messenger.

I prepared label in r/o the said seized motorcycle under the signature of the witnesses including police personal and the arrested accused persons. I supplied copy of seizure list to the accused person under his signature as mark of acknowledgement.

I pray that a specific case accordingly may kindly be started against the arrested accused person and to arrange its investigation.

The seizure list in duplicate and the label prepared also handed over along with the seized motorcycle for taking onward action by the I.O.
