On 06/11/2018 at 2.30 PM I got information from Mr. Biswanath Majhi, 10/11/2018 about the following facts:-
Mr. Biswanath Majhi is a resident of Raghunathpur, Dist. Purulia. He is a shopkeeper and runs a grocery store. He informed me that he had received a sum of Rs. 35,680/- (Rupees thirty five thousand six hundred and eighty) from a person named Mr. Biswanath Majhi on 06/11/2018. This amount was given to him by a man who claimed to be a police officer. The man was wearing a uniform and carrying a rifle. He also mentioned that the man had a mobile phone number ending in 619.

He also informed me that the man had a name tag on his uniform which read "Biswanath Majhi".
