




The petitioner/complainant most respectfully beg to state :-

- That the accused person was the owner a in possession of the land measuring 227 decimals in under Ranghamakapa, P.S. mouza Metyala covered R.S.Plet no. 42, Corresponding to C.S.Plot no.38 and other plots which he owned by way of purchase by virtue of register sale deed bearing no.1186 dated 01/10/1976 and the purchased land was shown in the sketch Map appended with the deed.
- That the accused person being the ownerof 227 2) decimals of land transferred 170 decimals of land out of above said land to one Mr. Sanat Sen by virtue of Registered sale deed bearing no. 1098 dtd. 29/4/1998






- 3) That thereafter the accused person, out of his remaining 57 decimal of land, he sold 4 decimals of land each to (1) Mr. Pradip Chakraborty, (2) Mr. Asish Karmakar and (3) Mr. Tapan Roy by virtue of Register sale deeds no. 1099 dtd. 29-04-2009, deed no. 1091, dtd. 04-0-.2009 and deed no. 7021 dtd.10-03-2010 respectively.
- 4) That in course of time the accused person along with the above noted three purchasers transferred jointly 15 decimals of land i.e. the above noted purchaser sold 12 decimal and the accused person 03 decimal to Mr. Sanat Sen of Kolkata by virtue of Register deed no.1421 dtd. 30-05-2013 and the transferred land was shown in the sketch map appended with the deed. After the sale the accused person had only 42 decimal of land in plot no.42.
- 5) That again the accused person transferred 33 decimals of land to Mr. Sanat. Sen by virtue of Register deed no. 1638 dt. 17-06-2013, thus the accused person transferred 218 decimals of land out of his above said Purchased land measuring 227 decimals and remain only 9 decimals of lard.
- 6) That it is to be pertinent to mention here that the accused person has been residing over the above remaining land measuring 9 decimals by constructing residential building there on and he had no others saleable land.

- 8) That the complainant along with his brother being desirous to purchase the above said land offered by the accused person accepted offer and contacted with the accused person and in negotiation fixed the price of the land amounting to Rs. 3,02,120/- and ultimately the sale deed was executed by the accused person in favour of the complainant and his brother Partha Chowdbury vide Register sale deed no. 693, dtd. 09-03-2017 having received the above said consideration money through account payee cheque from the complainant and his brother and the sale deed was registered attaching sketch map of the transferred land.
- 9) That after purchase while in the month or September, 2017 the complainant and his brother went to their purchased land with a view to raise Boundary wall, at that time, men of the above said previous purchaser Mr. Sanat Sen of Kolkata, raised objection and told the Complainant and his brother that, Sanat Sen has already purchased that land vide deed no. 1421, dtd. 30-03-2013 which has mentioned in para 4.

- 10) That having learnt the above said facts, the complainant started vigorous search and got all the certified copies of the above stated deeds from the office of the Sub-Register Raghunathpur on 23-10-2017 and become confirmed that the accused person had already transferred their purchased land in favour of Sanat Sen of Kolkata and the accused person again sold the same land to the complainant and his brother vide deed no 693 dtd. 09-03-2017.
- 11) That from the above stated facts it is evident that the accused person has practiced deception upon the complainant and his brother and thereby gain wrongfully and thus the accused person has committed offence of Cheating.
- 12) That having no alternative the complainant lodged complain before O/C Raghunathur P.S. but police took no action there after the complaint lodged before the S.P., Purulia on 06-08-2018 inspire of that the police has not taken any action till this day hence the complainant come before your honour for relief.
