Sir,

In producing herewith one accused person namely Bimal Bauri (30 Yrs.) S/o Mahadeb Bauri of Nanduaara, Ward No 12, PS – Raghunathpur, Dist- Purulia under arrest and the following seized articles under seizure list enclosed herewith: -

- 1) 18 (Eighteen) sealed bottles (CS) containing 600 ml each and labeled with Dilse.
- 2) Sale Proceed – Rs. 220/-
- 3) One plastic bag.

I do hereby lodge this complaint regarding that today (14.11.18) at about 19:05 hrs during my evening mobile duty received source information over telephone that the above noted accused person has been selling liquor illegally & clandestinely of his hotel styled as New Laha Hotel at Raghunathpur Town beside Purulia – Barakar pitch Road. On receiving the reliable source information I communicated with O/C Raghunathpur PS over telephone and as per his instruction I along with C/06 Debdas Mukherjee, C/077 Hemango Pati and C/853 Kiran Murmu rushed to the spot to work out the information. On arriving to his hotel styled as New Laha Hotel at Raghunathpur Town beside Purulia – Barakar pitch Road at 19:25 hrs. I apprehended the above noted person after a strong attempt and 04 (Four) customers seeing the Police party managed to escape. On close interrogation that apprehended person had disclosed his name & address as above mentioned. I asked him to produce any valid paper in support of selling that illicit liquor but he failed to produce any legal paper/document in support for selling such liquor. Accordingly I seized all those noted in the above after preparing proper seizure list and labeled duly signed by the accused person and accompanying party. After this I arrested that accused person namely Bimal Bauri (30 Yrs.) S/o Mahadeb Bauri of Nanduaara, Ward No 12, PS – Raghunathpur, Dist- Purulia after maintaining all formalities of arrest.

Under the above facts & circumstances, I pray before your honour that a specific case may kindly be started against the arrested accused person namely Bimal Bauri (30 Yrs.) S/o Mahadeb Bauri of Nanduaara, Ward No 12, PS – Raghunathpur, Dist- Purulia under proper section of law and arrange for investigation.
