I apprehended the above noted person after a strong attempt and 04 (Four) customers seeing the Police party managed to escape. On close interrogation that apprehended person had disclosed his name & address as above mentioned. Lasked him to produce any valid paper in support of selling that illicit liquor but he failed to produce any legal paper/document in support for selling such liquor. Accordingly I seized all those noted in the above after preparing proper seizure list and labeled duly signed by the accused person and accompanying party.
