Sir,

In producing herewith one accused person namely Samar Paul (46 Yrs.) S/o Lt. Santosh Paul of Mission Road, Ward No 8, PS - Raghunathpur, Dist.- Purulia under arrest and the following seized articles under seizure list enclosed herewith: -

- 1) 25 (Twenty Five) sealed bottles (CS) containing 600 ml each and labeled with Dilse.
- 2) Sale Proceed - Rs. 170/-
- 3) One plastic bag.

I do hereby lodge this complaint regarding that today (14.11.18) at about 19:25 hrs during my special mobile duty received source information over telephone that the above noted accused person has been selling liquor illegally & clandestinely of his hotel styled as Samir Hotel at Raghunathpur Town beside Purulia - Barakar pitch Road. On receiving the reliable source information I communicated with O/C Raghunathpur PS over telephone and as per his instruction I along with C/1220 Ajit Kr Kandu and C/741 Gobdin Ban rushed to the spot to work out the information. On arriving to his hotel styled as Samir Hotel at Raghunathpur Town beside Purulia - Barakar pitch Road at 19:45 hrs. I apprehended the above noted person after a strong attempt and 05 (Five) customers seeing the Police party managed to escape. On close interrogation that apprehended person had disclosed his name & address as above mentioned. I asked him to produce any valid paper in support of selling that illicit liquor but he failed to produce any legal paper/document in support for selling such liquor. Accordingly I seized all those noted in the above after preparing proper seizure list and labeled duly signed by the accused person and accompanying party. After this I arrested that accused person namely Samar Paul (46 Yrs.) S/o Lt. Santosh Paul of Mission Road, Ward No 8, PS - Raghunathpur, Dist.- Purulia after maintaining all formalities of arrest.

Under the above facts & circumstances, I pray before your honour that a specific case may kindly be started against the arrested accused person namely Samar Paul (46 Yrs.) S/o Lt. Santosh Paul of Mission Road, Ward No 8, PS - Raghunathpur, Dist.- Purulia under proper section of law and arrange for investigation.
