## To The Officer-in-Charge Raghunathpur PS

In producing herewith one accused person namely Kartick Bauri (30 Yrs.) S/o Tarapada Bauri of Vill.- Dhanara, PS - Raghunathpur, Dist.- Purulia under arrest and the following seized articles under seizure list enclosed herewith: -

I do hereby lodge this complaint regarding that today (17.11.18) at about 19:15 hrs during my  $2^{\kappa n}$  Evening mobile duty received source information over telephone that the above noted accused person has been selling liquor illegally & claudestinely of his Gumthi at Dhanara More beside Moutore - Rukni pitch Road. On receiving the reliable source information I communicated with O/C Raghunathpur PS over telephone and as per his instruction I along with C/464 Purna Chakraborty, C/929 Rajendra Das and NVP/1089 Swapan Paramanik rushed to the spot to work out the information. On arriving to his Gumthi at Dhanara More beside Moutore - Rukni pitch Road at 20:05 hrs. I apprehended the above noted person after a strong attempt and 03 (three) customers seeing the Police party managed to escape. On close interrogation that apprehended person had disclosed his name & address as above mentioned. I asked him to produce any valid paper in support of selling that illicit liquor but he failed to produce any legal paper/document in support for selling such liquor. Accordingly I seized all those noted in the above after preparing proper seizure list and labeled duly signed by the accused person and accompanying party. After this I arrested that accused person namely Kartick Bauri (30 Yrs.) S/o Tarapada Bauri of Vill.- Dhanara, PS – Raghunathpur, Dist.- Purulia after maintaining all formalities of arrest.

Under the above facts & circumstances, I pray before your honour that a specific case may kindly be started against the arrested accused person namely Kartick Bauri [30 Yrs.] S/o Tarapada Bauri of Vill.- Dhanara, PS - Raghunathpur, Dist.- Purulia under proper section of law and arrange for investigation.
