

Sir,

In producing herewith one accused person namely Biswanath Mondal (49 Yrs.) S/o Lt. Gobardhan Mondal of Vill.- Agaibari, PS - Raghunathpur, Dist - Purulia under **arrest and the following seized articles under seizure list enclosed herewith:-**

- 1) 25 (Twenty five) sealed bottles (CS) containing 600 ml each and labeled with DILSE.
- 2) Cash Rs. 220/- (Two hundred twenty rupees) as sale proceed.
- 3) One plastic bag.

I do hereby lodge this complaint regarding that today 28.11.18 at about 20:05 hrs during my evening mobile duty received source information over telephone that the above noted accused person has been selling liquor illegally & clandestinely of his hotel beside on Purulia - Barakar Road Road. On receiving the reliable source information I communicated with O/C Raghunathpur PS over telephone and as per his instruction I along with C/638 Lalchand Bag, C/431 Surendra Kr Dubey and C/1010 Samir Paramanik **rushed to the spot to work out the information. On arriving to the hotel styled as "APANJAN HOTEL" on Purulia - Barakar road near at Lachhmanpur More, I apprehended the above noted person after a strong attempt and five (05) customers seeing the Police party managed to escape. On close interrogation that apprehended person had disclosed his name & address as above mentioned. I asked him to produce any valid paper in support of selling that illicit liquor but he failed to produce any legal paper/document in support for selling such liquor. Accordingly I seized all those noted in the above after preparing proper seizure and labeled the seized articles duly signed by the accompanying party in the seizure list and the label. After this I arrested that accused person namely Biswanath Mondal (49 Yrs.) S/o Lt. Gobardhan Mondal of Vill.- Agaibari, PS - Raghunathpur, Dist - Purulia after preparing proper memo of arrest.**

Under the above facts & circumstances, I pray before your honour that a specific case may kindly be started against the arrested accused person namely Biswanath Mondal (49 Yrs.) S/o Lt. Gobardhan Mondal of Vill.- Agaibari, PS - Raghunathpur, Dist - Purulia under proper section of law and arrange for investigation.
