Sub: Complaint against Lakhiram Soren (45yrs) S/O-Lt. Rabibal Soren of Vill-Lediam Upar Para, PS - Santuri, Dist - Purulia to start a cog case U/S- 46A(C) B.E. Act 1909.

Respected Sir,

In producing here with the arrested accused person namely Lakhiram Soren (45yrs) S/O-Lt. Rabibal Soren of Vill-Lediam Upar Para, PS - Santuri, Dist - Purulia along with 12 (Twelve) liters Country Spirit (20bottle X 600ml) (Rs- 35 X 20= 700) seized under proper seizure list, I beg to submit that today at about 19.05 hrs I received a credible source information that one person namely Lakhiram Soren (45yrs) S/O-Lt. Rabibal Soren of Vill-Lediam Upar Para, PS - Santuri, Dist - Purulia is stocking and selling Country Spirit without any valid license from his dwelling house at Lediam vilage (Upar Para), P.S - Santuri, Dist - Purulia. Accordingly, I along with force had been to the spot for Lediam vilage to work out the source information and held raid into the premises of above mentioned accused person. I like to note here that seeing the Police personnel, customers were fled away. During search with the help of accompany force, we found that the said person is stocking Country Spirit bottles for sell. On demand, he failed to produce any valid documents/ License in respect of selling and keeping of Country Spirit bottles. Accordingly, I arrest him after preparing proper arrest memo as he committed offence U/S 46A(C) B.E. Act 1909 and supply one copy to him. Then, I seized and labeled 20 (twenty) bottle 'DIL SE' country spirit containing 600ml each bottle and amounting Rs-35/- (Thirty five) each bottle, Total amounting Rs-700/- under proper seizure list duly signed by the witnesses.

Under the above circumstances and fact, I therefore pray that a cog. case may kindly be started U/S 46A(C)B.E. Act 1909 against the arrested accused person namely Lakhiram Soren (45yrs) S/O-Lt. Rabibal Soren of Vill-Lediam Upar Para, PS - Santuri, Dist - Purulia and arrange for its investigation.
