Sub : Prayer for lodging FIR against accd. (1) Dhumbal Modak (42 yrs), S/O - Bhutnath Modak of Kankibazar (Beko colony), PS-Santaldih Dist- Purulia U/S 46A (c) B.E. Act 1909.

Sir,

In producing herewith arrested accused (1) Dhumbal Modak (42 yrs), S/O - Bhutnath Modak of Kankibazar (Beko colony), PS-Santaldih Dist- Purulia along with seizure - list and seized items as described below, I beg to state that on 28.11.18 at about 19.15 hrs during my raid duty, I received a source information to the effect that the foreign liquor and country liquor have been kept at Kanki Bazar (Beko colony) in the house of above noted accd. illegally with an object to sale. I convey the matter to duty officer SI Milon Manna over telephone. He has diarized the information under Santaldih P.S. GDE No- 881, dated- 28.11.18 and as per order of I.C Santaldih P.S. I along with force left for Kanki Bazar (Beko colony) to work out the information with the govt. supplied kits box containing white cloth, sealing wax, seal, papers, carbons, candles etc. I had been to the house of Dhumbal Modak at Kanki Bazar (Beko colony), P.S. Santaldih at about 19:35 hours. Seeing police some unknown persons in front of the house of Dhumbal Modak fled away.

However, I could detain one among them and asked about his identity. He revealed his name and identify as above and as well as informed also that he gather the country spirit for selling and he was the owner of the said house. However, I along with said accd. started a search inside the house of Dhumbal Modak and found the following item in the said house.

- 1) 32 (Thirty Two) bottles 80UP country spirit (Dilkhush) each bottles containing 600 ML market value of each being in total approx Rs. 1120/- (One Thousand One hundred twenty only)
- 01 (one) bottle of 600 ML taken out of the above as sample packet, labeled and sealed with sealing wax.

I interrogated him about the purpose of the stocking and possessing of the liquor said to be country spirit. He replied it was the business of him. On repeated question he told that the persons who fled away were his customers (names of those not known to him). However he could not show any documents/papers in support of the possession as well as sale of the said articles.

As such, I seized the above items as ALAMAT under proper Seizure List between 19:55 hrs and 20.35 hrs & took up one bottle of each brand as samples, labeled and sealed accordingly.

Since the allegation against him of possessing, the C.S illegally without any valid papers for the purpose of selling in his house has prima-facie been made out and for the interest of proper investigation. I arrested the above accused at 20.45 hrs accordingly.

Therefore, I pray before you to start a case under proper section of law against the said accused Dhumbal Modak (42 yrs), S/O - Bhutnath Modak of Kankibazar (Beko colony), PS-Santaldih Dist- Purulia.
