Sir,

In producing herewith one arrested accused person namely Bijoy Shaw S/O Lt. Banerwar shaw of Vill- Palashkola, PS-Adra, Dist- Purulia (1) one improvised pipe gun (Country made) having butt body barrel, (2) One 8 mm like live cartridge which was loaded inst-1 and seized after un loading (3) One old hero ZET by-cycle seized by under proper seizure list, I SI Bibekananda Ganguly S/O Lt Kariram Ganguly presently posted at Adra PS, do here by lodge complaint that on 17.12.2018 SI Bibekananda Ganguly at about 20:05 hrs O/C, Adra PS received a source information that one person aged about 40/45 yrs was moving near Jhankai Kali Mandir, Lower Beniasole, keeping possession of arms and ammunitions with a motive to commit any cognizable offence at the point of fire arms, the information was diarized in General Diary by O/C, Adra PS vide Adra PS GDE No 676 Dtd. 17/12/18 and he directed over telephone to work out the information as SI Bibekananda Ganguly was performing evening mobile duty at PS area vide CC No. 3423/18 Dt. 17/12/18. Accordingly I along with C/-122 Rabindra Kr. Verma, Jc/-1325 Sukhchand Singh had been to " Adra Raghunathpur pitch road near Jhankai kali Mandir" at Lower Beniasole, Adra at about 20:15 hrs. And watched the person from a distance after concealing himself behind a closed bush. SI Bibekananda Ganguly & force found that a person was moving suspiciously along the road and as the road was lonely at that time so, he was waiting by the side of a mango tree (at a distance of about 60 mtrs. from the Jhankai Kali Mandir) in order to commit any crime upon any pedestrian/motorcyclist etc. At the sight of Police the said person took to his heels and after a chase he was caught hold. On interrogation he disclosed his name as stated above. He was asked for his presence in such a lonely place at night and he made different statements at different times. Then SI Bibekananda Ganguly offered the said Bijoy Shaw to search him and his Police party before searching his body, but he refused. Then SI Bibekananda Ganguly searched his body and found one country made single shooter improvised pipe gun which was loaded with one 8 mm like live cartridge ammunition at his waist. SI Bibekananda Ganguly demanded for relevant license/document from him in respect of possessing the said fire arms and ammunition, but he failed to produce any such valid documents in respect of possessing the said fire arms and ammunition and could not give any satisfactory account in this regard which made him to believe that the accused person possessed those fire arms and ammunition illegally for some ulterior motive. So SI Bibekananda Ganguly seized (1) one improvised pipe gun (Country made) having butt body barrel, (2) One 8 mm like live cartridge which was loaded inst-1 and seized after un loading (3) One old hero ZET by-cycle from the exclusive possession of accused Bijoy Shaw under proper seizure list duly signed by Police witnesses and also by the accused person. SI Bibekananda Ganguly prepared label for the seized item. Then SI Bibekananda Ganguly arrested the above noted accused person after issuing Memo of Arrest & Inspection Memo and after obtaining all formalities and guidelines as laid by the Apex Court of India, NHRC and WBHRC as he illegally possessed fire arms and live ammunition to use those for unlawful purpose. SI Bibekananda Ganguly tried to collect public witnesses but as it was night and the place was lonely, he could not arrange for any public witnesses. Accordingly after returning at PS. SI Bibekananda Ganguly produced the arrested accused along with the seized fire arms and live ammunition with all relevant documents.

Under the above circumstances, I therefore pray that a case may kindly be started under proper sections of law against the arrested accused person Bijoy Shaw S/O Lt. Banerwar shaw of Vill- Palashkola, PS-Adra, Dist- Purulia and to arrange for its investigation.
