I Sri Amitava Choudhury Stole. Rajat Kr. Choudhury, DE & Station Manager of Balarampur CCC of WBSSEDCL do hereby lodge complaint against Sri Haladhar Mahato, Stole Bhabatosh Mahato resides at vill- Khukramukha P.O- Kantadik, P.S. Arsha, Dist- Purulia to the effect that received an information that the aforesaid accused person is committing theft of Electricity in his residence by way of making tapping in the incoming service cable to bypass the proper registration of units in the Energy Meter of WBSSEDCL.

Acting upon such information today on 20.12.2018 from 2.50 PM to 3.35 PM I along with Jiaur Rahman Mondal, DE, SLP Unit, Purulia Region, Sri Ramendra Narayan Sinha, SO (Retd. DSA), SLP Unit Purulia Region Sri Shankar Ch. Mahato, D.M, SLP Unit Purulia Region, Sri Dasgupta Mahato SLP Unit Purulia Region and Manab Kr. Maji, SAE, Balarampur CCC inspected the premises of Sri Haladhar Mahato and held raid.

During raid and inspection it was detected that accused Haladhar Mahato is using electricity dishonestly by way of making tapping in the incoming service cable to bypass the proper registration of units in Energy Meter of WBSSEDCL. Through this bypass arrangement he is using ceiling Fan - 4 Nos

LED Lamp (9watts) - 6 Nos, Fridge - 1 No & Colour TV - 1 No having connected load 0.594 kW. The service connection of WBSEDCL bearing consumer ID 201268741 stands recorded in the name of Accused, which has been disconnected on detection of theft of electricity.

Jiur Rahaman Mondal, DE (G&LP) prepared inspection report as per my instruction in presence of the Accused and assessed the load as 0.594 kW. Details have been mentioned in the inspection report, and duly signed by the Accused. The inspection ~~report~~ was carried after serving notice to the accused.

I directed Sri Shankar Ch. Mahato, L.M to disconnect the service connection of the above stated consumer ID. Accordingly they disconnected the aforesaid service connection and removed the bypass arrangement along with double pole change over switch.

~~Inspected~~ Jiur Rahaman Mondal, DE (G&LP) prepared seizure list as per my direction in presence of witnesses, details of seizure have been mentioned in the seizure list and obtained signature of the accused. The local people gathered there witnessed the incident but refused to sign on the seizure list and inspection report. A copy of seizure list was handed over to the accused.

For this activity of theft the WBSEDCL has sustained huge financial loss in terms of revenue.

It is well evident that the above mentioned accused person has committed offence u/s 135(i)(a) & 135(i)(c) of Electricity Act 2003 (Amended in 2007)

Kindly treat this complaint as FIR and take necessary action against the accused.
