I ,SI Sanjoy Diger of Arsha PS do hereby lodged a written complaint against the above noted accused person to the effect that today 03.12.18 at about 18:10 hrs during my evening mobile duty received source information over telephone that the above noted accused has been selling liquor illegally and clandestinely in front of his house at Aharrah village under Arsha PS, Dist- Purulia .On receiving the reliable source information I communicated with O/C Arsha PS over phone and as per his instruction I along with force C/-941 Istaque Ahamed, C/321 Ashis Mandal, C/751 Surajit Natu, C/211 Abhijit Garai all of SAP 7th Bn camp at Arsha PS rushed to the spot to work out the information. Reaching at Aharrah village we fixed-up the house of above noted accd, person and noticed that the selling country spirit was going on there and getting seen of police all customers were managed to escape, but we able to apprehended the above noted accused person. On demand he failed to produce any valid documents in support of selling country spirit. So I seized all the implicating articles as noted above under a proper seizure list from his exclusive possession in presence of witnesses and properly sealed and labelled duly signed by the accused persons and witnesses among which one bottle of country spirit and 500 ML of Cholai were kept as sample file with label. During interrogation he confessed his guilty so, I arrested him after observing all the formalities issuing memo of arrest as the accused persons are liable for prosecution u/s 46A(c) of The Bengal Excise Act, 1909.

I therefore pray that a specific case may kindly be started against the accused namely Bibhuti Majhi (55) S/O Lt. Jagannath Majhi of vill Aharrah P.S.-Arsha Dist-Purulia U/S 46A(c) The Bengal Excise Act, 1909, and arrange it's regular investigation.
