Apropos above this is to state that, as per the enquiry conducted by the concerned Revenue Inspector <sup>On 02-11-18 at 12-30 hrs Friday. S/o of</sup> Ashri Narrottam Kuiry S/o of Rabindranath Kuiry of Harup, P.O- Atna ,P.S.-Baghmundi, Dist.-Purulia is trying to fill-up water-body (about 1.74 acre) illegally in the Plot No. 59 (classification "Bandh" total area 10.00 acre) of Mouza Harup, J.L. No. 13. Out of 10.00 acre 1.74 acre area of this water-body is recorded in favour of above mentioned person and remaining area is vested to the state. Without any permission from concerned Department nobody could change mode of use of land or water-body of any description. It is also state that according to law no one could possesses particular area of water-body.

Above said persons violate Section 4(c) of WBLR Act as they filled earth in the water-body without prior permission from prescribed Department and violation of Sec.4(c) is liable to punishment under Sec. 4(D) of WBLR Act.

You are kindly requested to take necessary action accordingly and this letter may be treated as an F.I.R.


