I do hereby lodge complaint empowered by enabling the electricity act 2003 subsequently the amendment act 2007 to the effect that, Sri Himangshu Sukul, S/O- Sri Manarath Sukul of village Khirabera, P.O- Charida, PS- Bagmundi, Dist- Purulia has committed theft of electricity U/S 135(1) (a) of electricity act 2003 subsequently amendment act 2007.

On 20/12/2018 at about 1:40 P.m. I Sri Swapan Kumar Das, AE & Station Manager, Baghmundi CCC along with 1. Sri Kanulal Dey, Gr. I TSH 2. Sri Sajal Kumar Mahanty, OE 3. — entered the premises of Sri Himangshu Sukul, S/O- Sri Manarath Sukul of village Khirabera, P.O- Charida, PS- Bagmundi, Dist- Purulia and found Sri Himangshu Sukul was enjoying electricity unauthorizedly drawing power from the nearest L & MV line of WBSEDCL through PVC wire by means direct hooking to his house premises and connected load found 0.15 KVA. As Sri Himangshu Sukul S/O- Sri Manarath Sukul committed theft of electric power, So, I seized the following articles after preparing the seizer list in presence of 1. Sri Kanulal Dey, Gr. I TSH 2. Sri Sajal Kumar Mahanty, OE The inspection team left the premises at 1:50 P.m.
